All selections and forms must be returned on or before Friday, February 3, 2023 to secure your child's enrollment. ## **ABOUT SUMMER:**

Summer fun camp is exactly that - FUN! We plan activities and vendors that meet our high standards at LLA, and we continue our normal business hours. From water days to special guests like Puppets Pizzazz, we love how fun and engaging summer camp is for our students. The summer activity fee is \$325 for full time, 5 day students. Should you enroll, a \$100 non-refundable deposit will be applied to your March statement. The balance of \$225 is due by May 26, 2023. You also have the option to pay the summer activity fee in full.

#### **ABOUT FALL:**

LLA will continue following Creative Curriculum for fall, and our teachers are already establishing their themed weekly lesson plans. LLA is all about learning through play and supporting children as they navigate social and emotional growth as well, and we'll continue this for the 2023-2024 school year. Should you enroll, a \$150 non-refundable fall registration fee will be added to your account in May.

# ABOUT THE LOCAL TOWNSHIP/BOROUGH PRE-K LOTTERY:

The township/borough Pre-K lottery includes an opportunity for your child to be selected to attend a local public program. We celebrate children learning everywhere! LLA plans our staff and classroom structure based on enrollment of our students. It's important for us to know if children will leave us to attend a public program, so that we can open new placement options for incoming students and those that need full day operating options like we do. You will see a designation regarding Pre-K lottery on the next page. Please note, your selection on this topic will not affect your placement opportunity here at LLA! Your completed forms and payment of the registration fee allow us to hold space for your child. If you later choose the public Pre-K option, we will seek to provide the opening to another child. Please note, registration fees are non-refundable.

## **ABOUT TUITION:**

On the Registration and Tuition Contract, there is a necessary tuition increase of 7.25%. As we are seeing all around us, prices have risen for materials, services and many other operational needs. At this time, we are forced to pass through a portion of those increases by way of increasing tuition.
